



## Minimum Submissions for Informal Applications, Quick Quotes Streamlined

With a continuing focus on processing your business quickly and efficiently, MetLife will establish minimum submission guidelines for all informal applications, and will also reinforce the standards for the QuickQuote process.

Effective July 15, the new minimum submission amounts for informal applications will be \$500,000 for permanent products and \$1,000,000 for term products.

Also on July 15, the standards for QuickQuotes will be changed to streamline that process by reducing the size of your submissions to a brief, one-paragraph synopsis of the risk. Applications that include Attending Physician Statement (APS) summaries and records will now be handled as informal applications, and they will no longer be accepted as part of a QuickQuote.

MetLife's turnaround time for informal applications with APS summaries (3 days) has not changed.
